1. Questions and Answers:

1.01 Question: "Part 1:

"Part 1: Since many municipalities realize the importance of keeping their City in compliance with CalPERS when implementing staff augmentation programs; particularly with retirees, they often include supplemental provisions within their RFP or contract. Is the City considering incorporating such

supplemental provisions within its RFP?"

Part 2: Should the City decide to incorporate CalPERS compliance criteria to this RFP, how will it be evaluated and what evaluation percentage will be allocated for consultant

respondents that present compliance methodologies?"

Answers: Part 1 - No

1.02 Question: "Use of on-site Project Managers – Is the City's expectation that

the on-site project manager(s) working hours to be full time or

part time?"

Answer: It will vary depending upon the needs of the City.

1.03 Question: "Use of on-site Project Managers – what is the expected duration

the City would utilize each on-site project manager?"

Answer: It will vary depending upon the needs of the City.

1.04 Question: "Use of on-site Project Managers – How important is it that the

Project Managers be available for durations of longer than 6

months?"

Answer: It will vary depending upon the needs of the City.

1.05 Question: "Use of on-site Project Managers – Does the City have any

specific policies or concerns regarding the use of retired public

sector employees as project managers?"

Answer: The City does not have any preference or policy regarding

retired public sector employees.

1.06 Question: "Should proposals include qualifications for soils testing,

materials testing and survey services – or will the selected consultants' role be limited to coordinating the soils testing,

materials testing and survey services provided by others?

Answer: No, this RFP is only for the coordination of such services.

Survey, geotechnical and testing firms are not being solicited

under this RFP.

1.07 Question: "Do inspector qualifications require engineering licensure?"

Answer: No, most inspection requirements under this RFP will not require

an engineering license. However, there may be occasions when the City may ask if a firm has licensed engineers available to

inspect specific types of work.

1.08 Ouestion: "RFP Section V, "Proposal Format and Content," Section B,

"Licensing and Certification Requirements" asks for proof of licensure. Are license numbers and names of issuing organization/agency considered sufficient proof or should copies

of the actual licenses be submitted."

Answer: Just the license number and name of issuing organization/agency is

necessary. However, the proposal may include copies of the actual

license.
